

# Regulatory alert: MCA notifies Companies (Appointment and Qualification of Directors) Fifth Amendment Rules, 2019

Online proficiency self-assessment test for independent directors

Issued on: 11 November 2019

#### Summary

The Ministry of Corporate Affairs (MCA) on 22 October 2019 amended the Companies (Appointment and Qualification of Directors) Rules, 2014<sup>1</sup>. The amended rules introduce the requirement for every individual who has been appointed or intends to get appointed as an independent director (ID) in a company to include his/her name in the databank as maintained by the Institute<sup>2</sup>.

Further, the new rules also provide for the requirement by certain IDs to pass an online proficiency selfassessment test conducted by the Institute in order to keep their name in such data bank.

#### **Key highlights**

# Online application by IDs for including their name in the data bank

The following individuals shall make an online application to the Institute for including their name in the databank maintained by the Institute. The application can be for a period of one year or five years or for lifetime.

Who should apply	Timeline for making application
Individual who has been appointed as an ID as on 1 December 2019	Within 3 months from 1 December 2019
Individual who intends to get appointed as an ID after 1 December 2019	Before appointment

Voluntary application: Further, any individual, including an individual not having a Director's Identification Number (DIN), may voluntarily apply to the Institute for inclusion of his/her name in the data bank.

#### Renewal of the name in the databank

The individual may renew his/her information in the data bank for a further period of one year or five years or for lifetime, within 30 days from the date of expiry of the earlier inclusion period<sup>3</sup>.

**If not renewed**, the name of such individual shall stand removed from the data bank. Please note, an application is not required when the individual has lifetime registration.

#### **Declaration by IDs**

IDs shall submit a declaration of compliance with the above requirements to the Board each time they submit the declaration<sup>4</sup> with the company.

#### Online proficiency self-assessment test

Every individual shall pass an **online proficiency selfassessment test** conducted by the Institute:

- within **one year** from the date of inclusion of his/her name in the data bank, and
- with a score of **not less than 60%** in aggregate.

It is pertinent to note that the name shall stand removed from the data bank on failure to pass the test. However, there are limits on the number of attempts an individual may take for passing such test.

**Exemption:** The following individuals are not required to pass the online proficiency self-assessment test:

- Individual who has served for a period 10 years or more as on the date of inclusion of his/her name in the data bank as director or key managerial personnel (KMP) of:
  - a listed public company
  - an unlisted public company having a paidup share capital of rupees INR 10 crore or more

It has, however, been clarified that for the purpose of calculating 10 years, the period during which an individual acted as a director or KMP in two or more companies at the same time shall be counted only once.

#### **Our comments**

IDs perform functions that are critical to good corporate governance. The amended rules will improve their corporate literacy and will make the IDs aware of their duties, roles and responsibilities so that they can carry them out effectively.
