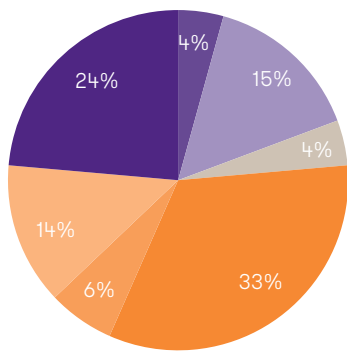

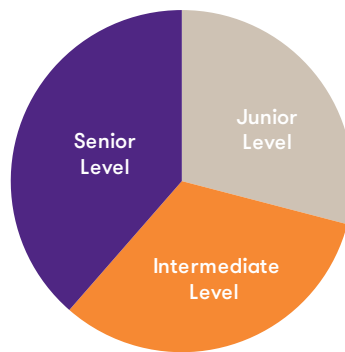

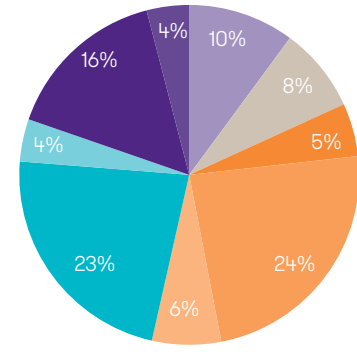

Domain

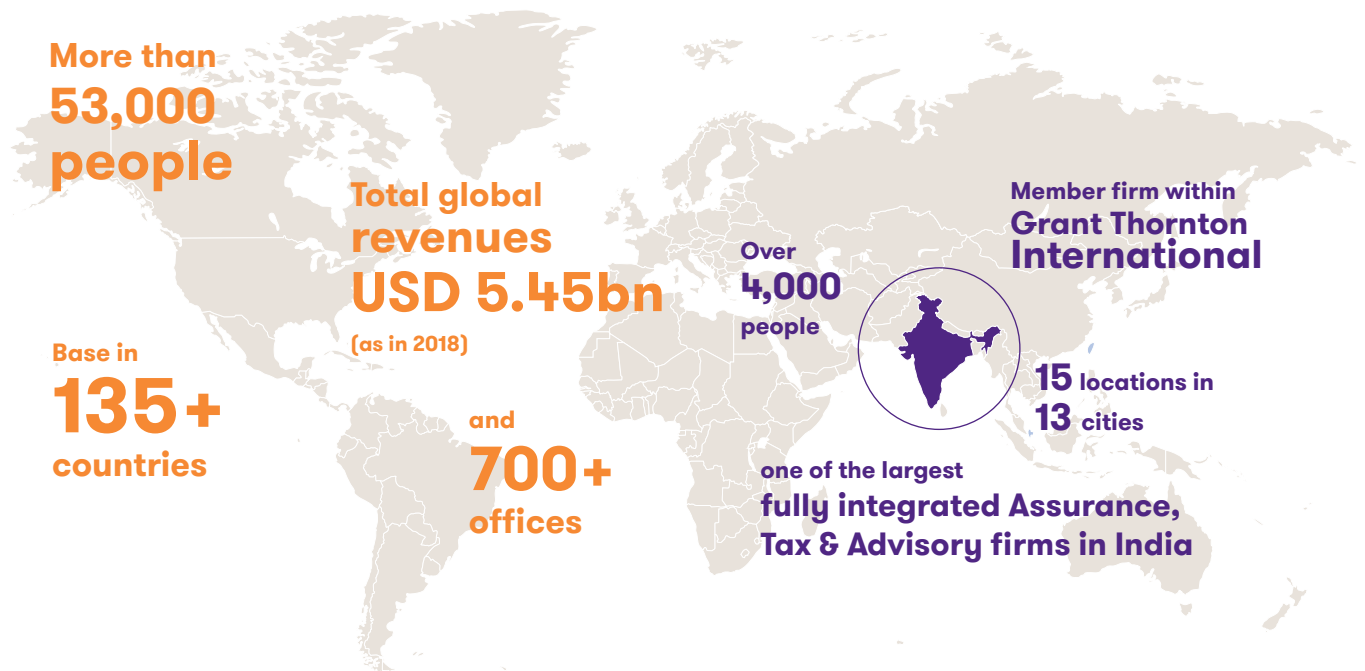
